Frederick M. Herrmann, Executive Director of the Election Law Enforcement Commission (ELEC), announced today that lobbying expenditures for the 1987 calendar year totalled \$7,737,950.

According to Herrmann this figure represents a 33 percent increase over the 1986 annual total of \$5,803,305.

Herrmann said that ELEC received 397 annual lobbying reports for the 1987 calendar year which represents a 10.3 percent increase over 1986 when only 360 reports were received.

"These reports depict the current trend of upwardly rising lobbying expenditures," stated Herrmann, "however, they do not give us the true impact of lobbying activity in the State because of a major loophole in the law. As the Commission has previously and repeatedly urged, reporting of lobbying expenditures that personally benefit their officeholder recipients must be reported to assure open and honest government."

Presently, only spending related to conversations about particular legislation is reportable. "This situation is not only unrealistic but also unenforceable," Herrmann said. Exacerbating this statutory shortcoming is the fact that the Commission has only one field investigator to cover the entire State for lobbying violations as well as all those in all other disclosure areas.

The portion of lobbying expenditures attributed to the passing of benefits, but only as the result of communication with legislators, the Governor, and his staff on particular bills, totalled \$28,180, an amount that is 26 percent less than the 1986 figure of \$37,993.

"A concerned citizen might wonder that the value of benefit passing has dropped while total spending has increased," Herrmann commented. "The loophole," he said, "may be widening."

Other detailed expenditures reported by lobbyists include: \$570,112 for distributing materials, \$121,620 for traveling, \$59,988 for hosting special events, and \$404,160 for paying membership dues.

"Indeed, lobbyists are providing some reporting pertinent to the political process," said Herrmann. "However, disclosure of benefit passing is what the public really needs to know and the time has come to bring a change to the lobbyist disclosure law to get it reported. It's not the talking but the treating that must be revealed."

Lobbyists are required to file an annual report with ELEC by February 15 if they have exceeded \$2500 in contributions or expenditures for the purpose of affecting legislation. "These reports list the contract lobbyists retained, specific bills lobbied, as well as detailed receipts and expenditures," said Herrmann.

In addition, quarterly reports of lobbying activity are filed with the Attorney General. "Consolidating filings would improve efficiency and effectiveness," stated Herrmann. He added, "administration and enforcement of the program should rest solely with ELEC so that lobbyists and the public alike do not have to divide attention between two agencies."

A number of bills currently before the Legislature contain the Commission's recommendations for improving the law.

ELEC is hosting the Northeastern Regional Conference on Lobbying (NORCOL), of which Herrmann is the current chairperson, on August 8, 1988 to focus on "Lobbying in the 90's" and to seek approaches to improving the disclosure of lobbying activities in New Jersey and the region.
